

General Sales and Delivery conditions of **Busch Vacuum Kft.**

1. The scope of the General Sales and Delivery conditions

(1) These Sales and Delivery conditions are valid in general conditions for the activities of Busch Vacuum Kft. (as trading, servicing and maintenance, repairing), except in case of different agreement.

(2) The rules regarding the issues not controlled by this document should be in accordance with the general Hungarian trading rules.

2. Quotations

(1) The Busch Vacuum Kft. gives price offers solely in written form sent to customers by fax or e-mail signed by the responsible contact person.

(2) The indicated prices are always net amounts in currency EURO. It is also possible to get an invoice in currency HUF applying the Raiffeisen Bank's official Corporate Selling Exchange Rate on the handing over or the accomplishment date. (3) The validity of the price offer is 30 days.

(4) The indicated lead times are expectations that can be a little bit longer or shorter depending on the delivery from the factory. The rights of earlier deliveries are reserved.

(5) If it is not otherwise specified the delivery parity is EXW Budapest as standard.

3. Orders and order confirmations

(1) The goods which are usually kept on our stock and its value are under € 500 can be ordered orally. The goods above this value or goods that have to be ordered separately will be delivered only after a written order (fax, e-mail, letter).

(2) We confirm the orders orally or in writing depending on its amount.

(3) If the order differs from our previous quotation it will be fulfilled according to our order confirmation.

4. Payment

(1) The payment can be based on EURO or HUF (Raiffeisen Bank's official Corporate Selling Exchange Rate) currency according to previous agreements.

(2) The invoice should be settled to the HUF or EUR bank account given on the invoice according to the payment currency. In case the money has not been transferred to the bank account indicated on the invoice the occurrent extra expenses because of any conversion or transfer should be carried by the sender.

(3) The Busch Vacuum Kft. reserves the ownership of the goods until its invoice has been settled in full.

(4) At cash payment the customer gets an invoice and/or a cash voucher and in this case the invoice will be sent by post later.

Deliveries, handing over the goods, accomplishments 5.

(1) The deliveries are usually in EXW Busch Vacuum Kft.'s premise. Any deviation can be based only according to the price offer or order confirmation on the buyers' own risk.

(2) The goods can be picked up during opening hours (Mo-Th: 9.00-15.00, Fr: 9.00-14.00), but in case of special requests different appointments also available.

(3) The Busch Vacuum Kft. hands over the goods to the customers' forwarder - referring to the customer's name - in case of an appointment. If the forwarder's arrival time is not known then its name should be known by us and the goods will be handed over to them or to the customer.

(4) If the payment condition is bank transfer the Busch Vacuum Kft. certifies the deliveries, fulfilling the maintenance or repairing works with delivery notes Maintenance and Repairing Report or with the undersigning of the copy of the relevant invoice.

6. Invoicing

(1) We invoice the goods that have been handed over with a delivery note within 3 working days.

(2) In case the invoice is in EURO currency the VAT is calculated in HUF as well, according to the Hungarian rules based on the MNB bank's official Exchange Rate on the invoicing day or the latest publication.

(3) If there is no special request the invoice will be sent to the invoicing address.

Service on customers' site, repairs 7.

(1) The repair and/or service of vacuum equipments can only be carried out by Busch Vacuum Kft. if a correctly completed 'Declaration about absence of Danger' form has been submitted. (2) The maintenance on the customers' site should be carried

out upon previous appointments when the undisturbed and safe work has been assured.

(3) The unexpected repair costs should be settled after the service/repair independently from the previous price offer/confirmation.

(4) The cost of dismounting or testrun for the quotation of the repairs will be charged to the customers.

(5) Busch Vacuum Kft. provides a 3 months warranty for the repairs of the vacuum pumps. If the customer orders only partial repairs against previous recommendations then there will be no warranty provided.

8. Warranty terms

(1) Busch Vacuum Kft. provides a 12 months warranty for the sold vacuum pumps from the purchase date.

(2) The warranty shall be applied if the pump was operated according to the Operational manual and the requested maintenance works have been fulfilled and recorded.

(3) If the complete system was installed not by the Busch Vacuum Kft. then the warranty shall be applied only for the machines and accessories delivered by us and we do not assume any liabilities for the damages of other items.

(4) The warranty for the spare parts are mounted by Busch Vacuum Kft. is 1 year assuming that the requested service have been done and the installation and operational prerequisites are correct. The regular wear and tear, lubrications and filters are not covered by the warranty.

(5) The warranty for the spare parts are mounted by a Busch certified service company is 6 months according to the condition of 8/(4).

(6) The Busch Vacuum Kft. does not provide warranty for the spare parts are mounted uncontrolled.

(7) We do not assume any liabilities regarding Force majeure (Act of God) and Third party fault.

(8) The expenses of the inspection of a failure is not covered by warranty should be carried by the customer.

(9) The warranty changes are carried out on the premise of Busch Vacuum Kft. The transport is the obligation of the customer. If the customer requires the warranty change on his site he should carry the transport costs.

The warranty after the due date of the relevant invoice (10)can be applied only for the already paid goods.

In case of warranty claim the Busch Vacuum Kft. start (11)the investigation within 5 working days after the notice
